## Volunteer Release and Waiver of Liability Form

Waiver and Release:** I, the Volunteer, release and forever discharge and hold harmless All Pets Education and Training and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to All Pets Education and Training. I understand and acknowledge that this Release discharges All Pets Education and Training from any liability or claim that I may have against All Pets Education and Training with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to All Pets Education and Training or occurring while I am providing volunteer services.

**2. Insurance:** Further I understand that All Pets Education and Training does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of All Pets Education and Training beyond what may be offered freely by All Pets Education and Training in the event of injury or medical expenses incurred by me.

**3. Medical Treatment:** I hereby Release and forever discharge All Pets Education and Training from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or
